



Cultivator Farm Program 2018 Farmer Application

Thank you for your interest in Piedmont Conservation Council's Cultivator Farm program. To apply for the program, please submit the following to the farm manager, Thomas Saile, at thomas@piedmontconservation.org:

- A completed farmer application
- A business plan. The plan should include the following sections:
 - Description of current business
 - Description of expected farming operations on site, including anticipated length of license
 - Plan for potential markets and marketing
 - Farm budget
 - Financial projections for first year on site

If you would like to submit additional information about your farming operation, you are welcome to do so.

Selection of Farmers:

Applications will be reviewed by a selection committee of Piedmont Conservation Council staff, board members, and project partners. Applicants will be evaluated using the following criteria:

- Production experience of the applicant
- Strength of business plan
- Ability to farm in a cooperative setting
- Overall diversity of applicants
- Overall diversity of farm products grown on site
- Applicant's commitment to farming and ability to commit time to farming operation
- Strong professional references
- Good match between available farm resources and applicant's ambitions

Timeline:

The priority deadline for applications is December 1. Applicants that meet this deadline will receive a response to their application by December 19. Those who are selected to move forward will have priority for plot assignments. Applications submitted after the priority deadline will be reviewed on a rolling basis. Applicants should expect to hear back from the farm manager with a decision on their application within four weeks.

Once an applicant has been approved, the farm manager will meet with them to answer questions and start drawing up their license agreement. Prior to signing the agreement, farmers will need to share:

- Copy of photo identification
- Proof of insurance
